Introduction

This Modern Slavery and Human Trafficking Policy relates to actions and activities during the financial year 2024 - 2025.

High Risk Activities

- 1.3 Due diligence: Victoria Guney is responsible for due diligence in relation to known or suspected instances of modern slavery and human trafficking.

Training

To ensure a good understanding of the risks of modern slavery and human trafficking in our business and supply chains, the Company requires all management teams to get training about modern slavery prevention training.
